**CALL TO ORDER AND APPROVAL OF MINUTES**

**TREASURER'S REPORT**

John Bertone reported that the Association is financially sound. He does not anticipate a dues increase for 2005 unless there are large insurance claims due to the Florida Hurricanes.

These include: re-roofing, painting using new improved latex paint, deck sealing using an improved deck finish, installation of new sprinkler backflow valves, installation of new deck railings that meet the latest safety code, deck repair and replacement and installation of new building light fixtures.**

**Bill also said that the new rules for remodeling will be mailed to the Properties Owners in November. These rules mandate that any internal remodeling plans must be approved for structural integrity by a licensed civil or structural engineer, reporting to the Association, before remodeling can begin.**

**Bill then had a discussion with, and answered questions from, the attendees.**
