TREASURER'S REPORT

THE BOARD APPROVED THE FOLLOWING ITEMS

- Financial statements for the year 2001.
- Expenditure of the following sums from the Reserve Fund:
 - \$10,500 for deck replacement at units 21 to 24.
 - \$12,000 for building repairs.
 - o \$9,232 for parking lot paving near units 71,112 and 116.
 - o \$6,320 for dumpster pads and walkways for units 104 to 109.
 - \$7,953 for pavement sealing.
 - \$13,500 budget for pool remodeling.
 - \$6,900-\$8,500 for fence at upper pool.
- Implementation of the following buoy program:
 - Remove all but 19 buoys at the end of the summer, and get approval for these buoys from the TRPA. At the same time apply for a TRPA variance for an additional 50-60 buoys.

PROJECT MANAGER BILL BAUDER'S REPORT- COMPLETED AND ONGOING PROJECTS

 Spring cleanup including tree removal, sprinkler turn on, beach opening, buoy installation etc.

LEGAL INSURANCE COMMITTEE REPORT

• The Board is aware of no ongoing Rocky Ridge Properties litigation.

OLD BUSINESS

 Plans for the Bill Doolittle memorial BBQ at the beach area are nearly complete.

NEW BUSINESS

- Pricing for pathway Pavers for all the RR units will be obtained.
- Metal coverings will be tried on some rafter tails to see if they will furnish better protection than paint.
- Rules for contractors working at RR will be written to assure that they are licensed and bonded and that they make minimum disruption at neighboring units.
- In Burton Creek State Park-adjacent to Rocky Ridge-the State plans new trailheads that should not generate significant foot traffic near Rocky Ridge.
- Freeze alarms for each unit, hard wired to a central monitoring station, were discussed.

• The salaries of the permanent employees were discussed.
