MINUTES OF October 21, 2002 ROCKY RIDGE PROPERTIES OWNERS BOARD OF DIRECTORS MEETING

CALL TO ORDER AND APPROVAL OF MINUTES

- Board President Mel Gianola called the meeting to order at 1:07 PM in Room 422, 851 Burlway, Burlingame.
- Board members Ted Jones, Marsh Shambarger, and Bill Trevor also attended the meeting.
- Bill Bauder, John Bertone, Ray O'Neal and John Paul Hanna Esq., of Hanna and Van Atta, also were present.

DISCUSSION WITH JOHN HANNA ABOUT THE BY-LAWS AND CC&R'S

- The Board met with John Hanna to review the interpretation of, and consider possible changes to, the By-Laws and the CC&R's. Presented below is a summary of some of the items considered:
 - By-Laws Article III, Item 3.1: Changing the time of the Annual Meeting to be between 11:00 AM and 2:00 PM on the Saturday before Labor Day.
 - <u>CC&R</u>: In several places, changing references to the "Walsh Lot" to include an undeveloped lot at the bottom of Rocky Ridge Road. Bill Bauder is to determine the exact legal status of this lot.
 - <u>CC&R</u>, <u>Article V</u>, <u>A-Maintenance</u>: The definition of items to be maintained by RR Properties Owners Association.
 - <u>CC&R</u>, <u>Article V</u>, <u>B</u>, <u>Insurance</u>: The definition of specific items that are covered by the Association Hazard and Liability Insurance Policy.
 - o <u>CC&R</u>, <u>Article VII</u>, <u>Use Restrictions</u>: Use restrictions applicable to the various units, including multiple-ownership and time sharing.
 - By-Laws Article VII: That Reserve Fund Monies can only be used for items specifically included in The Reserve Fund.

APPROVAL OF THE MINUTES

Approved the minutes of the 8-31-2002 Board Meeting.

TREASURER'S REPORT

John Bertone presented the treasurer's report, the December 31, 2002
Reserve Study and the 2003 Annual Budget. The individual Properties
Owners quarterly assessment for 2003 is \$1769, which is a quarterly
increase of \$294 (19.9%) from the \$1475 quarterly assessment for 2002.
This increase is primarily caused by the increased costs of insurance,
including workers' compensation insurance.

THE BOARD TOOK THE FOLLOWING ACTIONS:

- Approved the 2003 Budget.
- Approved the December 31, 2002 Reserve Study.
- Appointed a committee consisting of Mel Gianola, Ted Jones and Bill Trevor to consider the advisability of amending and updating the CC&R's.
- Approved the inclusion, with the November mailing, of Bill Bauder's "Winterizing Recommendations for Owners".

OLD BUSINESS

- Bill Trevor will write a letter to the owner of unit 38 explaining that the two architecturally non conforming windows that were installed must be replaced with architecturally conforming windows.
- Bill Bauder has removed our temporary buoys and is applying to get reapproval of our legal buoys.
- Reinstituted a water damage claim for unit #122.
